The Transplant Coordinator Nurse is accountable for the coordination of all aspects of care for the transplant patient population. Assesses and plans in collaboration with the patient, caregiver, and multidisciplinary healthcare team to meet needs across the care continuum. Assesses data reflective of the patient's status and appropriately interprets information relative to the patient's age-specific needs. Provides patient and family education on a consistent basis. Provides leadership through activities such as community involvement, committee work, and participation in quality improvement and research. The American Nurses Association (ANA) Nursing: Scope and Standards of Practice, the ANA Code of Ethics for Nurses, the United National Organ Standard's (UNOS), and the Foundation for the Accreditation of Cellular Therapy (FACT) guidelines provide the basis for practice. Graduate of a baccalaureate Accreditation Commission for Education in Nursing (ACEN) or Commission on Collegiate Nursing Education (CCNE) accredited nursing program. Minimum 1 year of clinical RN experience required, 3 years preferred. Must be able to work flexible hours and adapt to unpredictable situations within the patient care setting. Demonstrated leadership ability and interpersonal effectiveness required. Ability to work both autonomously and in a team environment. Strong communication, critical thinking, problem solving, and computer skills required. Current RN license by applicable state requirements. Arizona and Florida - Maintains Basic Life Support (BLS) competency. Midwest - Maintains current Basic Life Support for Health Care Providers from one of the following programs: American Heart Association or American Red Cross. Coordinators in Transplant must obtain either Certified Clinical Transplant Coordinator (CCTC) or Certified Clinical Transplant Nurse (CCTN) credential within three years of hire. Coordinators in Bone Marrow Transplant must obtain Adult or Pediatric Oncology Certification (OCN or CPHON), or Bone Marrow Transplant Certified Nurse (BMTCN) credential within three years of hire. Recertification must be maintained for the duration of the employee's tenure in the transplant position. Additional specialty certification/training may be required by work area.

Sierra Donor Services is seeking an Administrator On Call to join our team in Sacramento, CA!

The Administrator On Call (AOC) has direct oversight of day-to-day organ program operations and activities related to identification, evaluation, approach, clinical management, allocation, recovery, and coordination of donor-related activities. The AOC will participate in an on-call capacity, as well as provide onsite mentorship, training, and education to the Organ Procurement Team. Additionally, this position is focused on staff development, case reviews, and overall support to increase the number of lives saved through organ donation.

Below are some of the key accountabilities this position will hold:

1. Provides on-call administrative services to meet the needs of referring hospitals, hospital personnel, physicians, donors, and donor families.
2. Supervises the day-to-day activities of staff. Ensures adherence to standard operating policies and procedures. Ensures the timely provision of all potential donor evaluations, standard approach, obtains authorization, donor management guidelines, organ allocation and organ recovery services.
3. Manages the call schedule to ensure adequate staffing levels.
4. Will participate in external and internal committees to represent clinical services and the entire organization.
5. Will interact with Medical Directors and Medical Advisory Committee and ensure regulatory compliance.

The ideal candidate will have the following attributes:

1. Bachelor's degree or equivalent combination of education and experience required.
2. 5 years of experience as an Organ Recovery Coordinator with donor management/oversight.
3. RN/PA/Paramedic license required
Working knowledge of computers including Microsoft Office, strong data entry and typing skills required.
4. Advanced clinical skills and a demonstrated ability to drive results to improve processes and outcomes.
5. Successful demonstration of strong initiative, collaboration, and communication skills with discretionary decision-making ability.

Position Summary

The Clinical Transplant Coordinator is a professional designated member of the transplant health care team who will be assigned primary responsibility for coordinating clinical aspects of care. The coordinator will work with patients and their families beginning with the evaluation for transplantation and continue through and after transplantation, in a compassionate and tactful manner in order to facilitate access to and provide continuity of care. The coordinator will also work with other members of the transplant team, including physicians, surgeons, nurses, social workers, financial coordinators, and administrative personnel at the transplant program. The Clinical Transplant Coordinator performs independently and seeks support/direction as needed. The Clinical Transplant Coordinator must be able to demonstrate the knowledge and skills necessary to provide care appropriate to the age of their patients; demonstrate knowledge of growth and development; assess data reflective of patients status; and identify each patients requirements relative to age specific needs.

Education

Bachelor's degree in Nursing is required.

Experience

Generally requires 3 to 5 years of related experience.

License/Certification

- Valid Florida RN license is required.
- American Heart Association (AHA) Basic Life Support (BLS) for Healthcare Providers certification with at least 6 months validity required.
- Must meet and maintain valid and current all unit specific and organizational skills/competencies, certifications/licensures, as required by regulatory and/or nursing standard of practice for the specialty.
